

**STEM School Highlands Ranch  
High School Physical Education Waiver Guidelines**

**General Information, Guidelines, Expectations:**

In order to qualify for a Physical Education Waiver a student must meet each of the following:

- Must be a full time high school student of STEM School Highlands Ranch.
- Student needs to be registered and an active participant in an approved sport/activity that requires at least 70 hours of participation per semester.
- The consent form must be signed by a parent or legal guardian regardless of the age of the student.
- The application must be signed by the sport/activity coach.
- The application must be signed by a high school counselor.
- The application must be approved by a high school administrator.
- The waiver form must be submitted by the due date for the semester of participation.
- A student kept timesheet/activity log must be submitted with the completed application.
- If a student leaves a program for any reason, he/she will be required to complete a STEM class to meet the PE credit requirement.

**Note:**

**Students may utilize this waiver policy to satisfy the Physical Education requirement, but will not earn any academic credit. Students are still required to complete a minimum of 24 credits to graduate.**

Parents/guardians are responsible for all costs associated with enrolling the student in the sport / activity that satisfy the requirements of this policy. STEM School is not liable for any costs/fees associated with being a part of the sport / activity, nor is the school liable for any physical injuries that may occur while using the Physical Education Waiver.
